I understand that this is a high-risk sport, I hereby assume all risks and further release and hold harmless the Organizer, organizing committee, all landowners, employees and volunteers from all liability for negligence resulting in accidents, damage, injury or illness to myself and my property, including the horse or horses with which I will be participating in this XC Schooling Day. I agree to abide by rules as set forth on the course.

Under North Carolina Law, an equine activity sponsor or equine professional is not liable for an injury to, or the death of, a participant in equine activities resulting from the inherent risks of equine activities. Article 99E of the North Carolina General Statutes.

I understand that all provisions of the USEA Release Form also apply to, and are incorporated by reference, into this TR&HC Release Form. This includes the requirements that riders wear:

- **Protective headgear** passing or surpassing the ASTM/SEI standards with harness attached that meets standards currently imposed by the US Equestrian Rules for Eventing
- **Body protecting vests** that meet or exceed current USEF rules
- **Medical armband or bracelet** the meets USEA/USEF approval

Also, **all riding is to be supervised/accompanied by a coach/trainer/instructor/grounds person** as required by USEA.

I understand and agree that TR&HC may refuse entry or require withdrawal from the grounds with regard to wearing of safety equipment as well as the conduct and well-being of rider, horse, and others on site; and prohibit, stop or control any action TR&HC deems inappropriate or unsafe.

I understand that the sport of eventing is a high risk sport, and that my participation in this educational activity may also involve participation in an "equine activity" as defined by applicable laws and is solely at my own risk. I understand that my participation involves all inherent risks associated with the dangers and conditions which are an integral part of equine activities, including, but not limited to, the propensity of equines to behave in ways which may result in injury, harm or even death to humans or other animals around or near them; the unpredictability of equine reaction to sounds, sudden movements, smells and unfamiliar objects; persons or other animals; hazards related to surface and subsurface conditions; collisions with other equines or objects; sickness and disease (including communicable diseases); and, the potential of a participant to act in a negligent or unskilled manner which may contribute to injury to the participant or others, including failing or inability to maintain control over the animal. By participating in this activity **I agree** to assume responsibility for those risks, and **I release** and agree to hold harmless the activity organizer, organizing committee, officials, the USEA, USEF, their officers, agents, employees and the volunteers assisting in the conduct of this USEA educational activity and the owners of any property on which it is to be held, from all liability for negligence resulting in accidents, damage, injury or illness to myself and to my property, including the horse(s) which I may ride.

Registration	Pre-register through TR&HC at 828-351-9709 or office@trhc1925.org Pre-registration allows a rider or trainer/instructor to reserve time at the water jump On-site registration is available and water jump slots will be assigned based on availability All participants are welcome to use the water jump throughout the day, if it is vacant
On-Site Check-In	Located in the parking area - across the street from the main entrance Payment will be collected at check-in along with all applicable forms Bridle numbers will given and must be worn to use the xc course
Release Forms Required	There are 2 releases: one from USEA and one from TR&HC Both are available on the TR&HC website - bring completed form with you For those under 18, a parent or legal guardian signature is required Trainer/instructors may not sign in place of a parent/guardian
Acknowledgement	Riders will be asked to sign an acknowledgment that they will ride with protective equipment and their covid status (and requirements) at check-in
Supervision Required	This is a USEA event, and thus all riders must be supervised/accompanied. Riders shall bring a coach/trainer/instructor/or other grounds person with them to school.
Protective Gear Required	Protective Headgear - with harness attached Body Protecting Vest Medical armband/bracelet All 3 items must be worn while jumping!
Jumps	Beginner Novice through Preliminary Fences will be available
Other	Valid, legible Coggins required Bring water for horse(s) for drinking and cool down Overnight stalls are available for rent through FENCE office.
