TR&HC Community Giving Program Guidelines

Please review the below guidelines before beginning your application.

- Applications are reviewed on a quarterly basis and should be received by the end of each quarter for consideration: March 31, June 30, September 30 and December 1 (for year-end). Applications should be e-mailed to: office@trhc1925.org.
- 2. If a question does not pertain to your organization, please explain why, or indicate as not applicable "NA."
- 3. Grants are made to non-profit, charitable organizations, which are tax exempt under Section 501(c) (3) of the Internal Revenue Code, or to schools and government agencies. In general, grants will be awarded in sums ranging from \$500 to \$5,000. Only organizations that operate within Polk County and surrounding communities (Rutherford and Henderson counties in NC) and (Spartanburg and Greenville counties in SC) are eligible for consideration.
- 4. We generally do not consider requests from:
 - Individuals
 - Fraternal, labor or veteran groups
 - Partisan political organizations
 - National organizations
 - Organizations employing full-time fundraisers who take a percentage of dollars raised
 - Organizations which practice discrimination based on race, religion, color, gender, disability, sexual orientation, or national origin
